Working Capital will take 3 to 4 years to track back to \$0.

- The draft Budget 2019 was discussed. The operational grant will increase due to the increased roll. The draft budget puts us in a position to reduce the Working Capital deficit by \$100,000.00. Heating a new contract has been signed to decrease costs. The draft budget has been sent to the Ministry and Steve Dunbar who will meet with us in March.
- Meeting dates have been confirmed.
- Analysis of Variance was discussed. A significant number of level 1 students left last year during the year, around 30. This year working hard on intervening with the identified level 1 students.
