Operating Result - 12 months to 31 December 2020:

- As at 31 December 2020 the negative working capital deficit figure has improved significantly and we have a forecast reduction in the negative working capital at year end of a conservative \$100,000.00.
- The audit for 2020 is now underway. Solutions & Services who prepare our annual accounts have already reviewed the schools financial transactions for the year and are close to finishing the draft annual accounts ready for audit. Our auditors have access to the schools online accounting system for audit purposes.

- Draft 1 of the budget for 2021 was presented to the Board in December 2020. Steve Dunbar has been invited to the finance meeting in March 2021 to review and discuss the final draft budget for 2021 and the draft annual accounts 2020.
- The reported figures as at 31 December are cash results and subject to balance day adjustments by Solutions & Services in our annual accounts.

The operating surplus for the 12-month period is \$130,370.00. Favorable variance of \$99,914.00 compared to the budget of \$30,456.00.
